ATTORNEY GENERAL WARNING OF OVER-THE-COUNTER HEARING AIDS

The Attorney General's office is alerting consumers to beware of some misleading tactics by over-the-counter hearing aid companies that make false claims of performance.

There are a lot of options for the hearing impaired that need hearing assistance, but quite honestly some of these products are not much better than putting your hand up behind your ear. Be careful and do your research so you don't add a money loss to a hearing loss.

It's estimated that nearly one in five Americans suffer from hearing loss.

Congress legalized the sale of over-the-counter (OTC) hearing aids in 2017. They have recently become available to the public.

These OTC products are not intended for adults or children under 18 with significant hearing loss.

Follow these guidelines when purchasing hearing aids and similar products:

- Be evaluated by a medical professional, such as ear, nose and throat specialist, ear specialist or any licensed physician. These professionals can assist you in the proper products that will help.
- Hearing aids should be fitted by an expert, such as a licensed, certified audiologist or doctor of audiology.
- Check the Better Business Bureau's website (bbb.org) for ratings.
- If a deal seems to good to be true, it likely is!

AVOID HEARING AID ADS WITH PICTURES AND PRICING

Hearing aid ads can be misleading. Companies often advertise prices too good to be true. Avoid bait-and-switch ads with hearing aid pictures and prices. Some companies use the word audiology as part of their business name when they do not employ audiologists on site.

Trust your hearing to a professional.

Avoid offers for free hearing tests. These tests are not typically performed by audiologists. Audiologists are the only professionals who are educated and trained to evaluate and treat hearing, balance and related disorders. Hearing loss can affect people of all ages and in many different ways. Early detection and appropriate intervention by a licensed, certified audiologist or doctor of audiology is essential for long-term disability effects to be avoided or minimized and communication, the human factor, to be enhanced.

If you are experiencing:

- Hearing loss or change in your ability to hear
- Ringing in the ear or ear noise (tinnitus)
- Trouble understanding speech, especially in background noise
- Having to ask people to repeat themselves
- Difficulty understanding people when you cannot see their face or you are on the phone
- Difficulty following group conversations

Tinnitus Technology Products

Tinnitus is a sensation of hearing sound (hissing, buzzing, whistling, roaring, chirping, etc.) in your ears or head and is commonly the result of hearing loss. Tinnitus technology products are available at Davison Audiology and will deliver personalized relief for each individual. The technology is customizable, and provides a comforting sound stimulus that is designed to deliver all-day relief from irritating tinnitus. All devices are available on a 60-day trial following a comprehensive hearing evaluation.

WHAT CAUSES TINNITUS?

Scientists and health experts don't know the exact physical cause of tinnitus, but several sources are known to trigger or make tinnitus worse, including:

- Loud noises and hearing loss Exposure to loud noises is the biggest cause of tinnitus. It can destroy the nonregenerative cilia (tiny hairs) in the cochlea, causing permanent tinnitus and/or hearing loss.
- Aging As you age, those same cilia gradually deteriorate, which can lead to tinnitus and/or hearing loss.
- Ototoxic medications Some prescription medications such as antibiotics, anti-inflammatories and antidepressants are harmful to the inner ear as well as the nerve fibers connecting the cochlea to the brain.
- Hearing conditions Conditions such as otosclerosis and Ménière's disease are known to cause tinnitus.
- Health conditions Tinnitus can also be a symptom of health conditions like cardiovascular disease, hypertension, diabetes, stress and head injuries.

Hearing Tests

No one is ever too old or too young to have a hearing test. Hearing loss can affect people of all ages and in many different ways. Hearing tests identify the type and extent of hearing loss and indicate the appropriate treatment.

Newborn or Infant Hearing Tests

Hearing loss may be present at birth or occur after due to illness or injury. Since children learn speech and language from listening to other people talk, the first few years of life are especially critical for this development.

Hearing Tests for Young Children and Teens

Children and teens may experience an unexpected hearing loss at any time. Since noise can also be a factor, protect your children from noise-induced hearing loss while using ear level electronic devices. Regardless of prior hearing screening outcomes, children and teens who demonstrate hearing loss symptoms should receive ongoing audiologic monitoring.

Real Ear Measurement (REM)

REM provides verification for hearing aid fittings to ensure that maximum benefit is received from the device. It is now possible to "see" the amount of amplification that is reaching the ear. Adjustments to digital hearing aids are made at the time of the visit.

In addition, REM allows us to simulate hearing loss for family members or friends for better understanding of the way the hearing-impaired person hears everyday sounds. For this reason, when possible, bring someone to the appointment with you.

If you suspect a hearing loss, or are experiencing ringing in the ears, then you should schedule an appointment at one of our locations to meet with a licensed, certified audiologist or doctor of audiology.



TYPES OF HEARING LOSS

- Sensorineural hearing loss (SNHL) is permanent and results from changes in the inner ear (cochlea) and/or the auditory nerve.
- 2. Sudden sensorineural hearing loss (SSNHL) is a serious condition and should be treated as a medical emergency.
- 3. Conductive hearing loss (CHL) is often correctable and results from changes in the outer ear and/or middle ear.
- **4. Mixed hearing loss (MHL)** results from the diagnosis of both a SNHL and CHL in the same ear.



COMMUNICATION STRATEGIES FOR AN INDIVIDUAL WITH HEARING LOSS:

- Always face the individual speaking to you.
- Decrease as much environmental/background noise (television, radio) as you can.
- · Ask the speaker to rephrase.
- Advocate Make sure your communication partners are aware of your hearing loss.
- Amplified telephones If you have any degree of hearing loss, even a very mild one, an amplified phone may help to improve your ability to understand telephone conversations.
- Captioning telephones A captioning phone provides real-time, word-for-word captions. Davison Audiology provides these phones free of charge through Captel.
- Video calling Video calling or conference call applications like Face Time or Skype can be used on a computer or mobile device.

QUICK FACTS

Heart Disease and Diabetes

It is believed that cardiovascular disease (CVD) can reduce blood flow to the ear and in turn cause damage to different parts of the auditory system. In addition, elevated blood sugar may be damaging the blood vessels and inner ear.

Depression

Untreated hearing loss, social isolation, and depression can all contribute to an overall poorer quality of life.

Age-Related

The "use it or lose it" principle applies to our ears. Unmanaged hearing loss can lead to deteriorated understanding of speech over time.

Dementia

- Hearing loss leads to social isolation which is a known risk factor for dementia
- People with hearing loss work very hard to listen to and understand speech, often at the expense of memory

COVID

New research also indicates that hearing loss could be a 'long COVID' symptom.

Fall Risk

Audiologists identify, diagnose, and provide treatment options for patients with vestibular disorders that lead to dizziness and imbalance.

FREQUENTLY ASKED QUESTIONS

Does Medicare pay for hearing services?

Medicare pays for the first hearing test. Future hearing tests are also covered depending on patient symptoms and degree of hearing loss. Medicare does not pay for hearing aids.

What types of insurance do you accept?

We bill most insurance plans. We are a provider for West Virginia Workers' Compensation, Ohio Workers' Compensation, UMWA, Medicare, Medicaid, and other insurance carriers. Contact the Business Office at 740.695.1058 or contact your insurance carrier regarding coverage of a hearing test or hearing aid.

Do you offer hearing aid trials?

We offer 60-day trials, the longest in the industry, a 2-month opportunity to evaluate products and return them for credit if not fully satisfied.

How will I pay for my hearing aids?

It is possible that your insurance carrier will cover some or all of the expenses. We accept cash, checks, and all major credit cards.

What other products do you provide?

We provide tinnitus devices, custom swim/water molds and hearing protection, as well as assistive listening devices such as amplified telephones, TV listeners, alarm clocks and doorbells, etc.
